AN ORDINANCE AMENDING THE CODE OF THE CITY OF CAMDENTON, TITLE IV: ZONING CODE, CHAPTER 400: ZONING REGULATIONS, SECTION 400.030: DISTRICT BOUNDARIES, REZONING PROPERTY BRIEFLY DESCRIBED AS LOT 1 OF CAMDENTON CENTER SUBDIVISION IN CAMDENTON, MISSOURI, A SUBDIVISION OF RECORD IN CAMDEN COUNTY, MISSOURI, FROM C-2 HIGHWAY COMMERCIAL DISTRICT TO R-3 MULTI FAMILY RESIDENTIAL DISTRICT

Section 1. That the Code of the City of Camdenton, Section 400.030 - District Boundaries, is hereby amended by changing the property described in Exhibit A attached hereto and made a part of this ordinance from C-2 Commercial Highway District to R-3- Multi Family Residential District.

Section 3. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 4. This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and approval by the Mayor.
