Dog and Cat Tags (City Code – Chapter 210)

Pot Bellied Pigs (City Code – Chapter 215)

Yard/Garage Sales (City Code – Chapter 625)

Burn Permit Call 346-3262 for recorded instructional information

Merchant and Liquor License (City Code – Chapter 600 & 605)

Building Permit Before remodeling or new construction contact City Hall for information on how to obtain a building permit (Includes: fences, decks, storage shed and/or swimming pools)

WATER/SEWER BILLING INFORMATION (City Code 700.295)

Meters Read: 24th or 25th of each month

Bills Mailed: by the 10th of each month for previous month usage

Water Bills Due: by the last day of the month

Late Penalty Added: 4th day of the following month

Late Notice Phone Calls: 4th day of the month

Disconnect Phone Calls: NO LATER THAN 24 HOURS PRIOR TO DISCONNECT

Disconnects: after the 10th day of each month, City Code 700.270

Reconnect Fee: \$25 during business hours (8 am to 3:15 pm) for the first time disconnected, \$50 during business hours for the second time disconnected and \$100 reconnect fee for 3+ disconnects in a 12-month period
